1. RECORDAL

- 1.1. The mandate of the UIF in relation to labour market activation, as expressed in section 5(d) of the Unemployment Insurance Act, 2001 (Act No.63 of 2001) (hereinafter, UI Act) is to fund programmes that result in job creation, job preservation and labour market re-entry. The UIF is therefore prioritizing funding programmes that lead to sustainable job creation and sustainable business ventures that will stimulate the South African economy.
- 1.2. The UIF has agreed to partner with the Partner for the Job Creation Programme, for the duration in Annexure A and the implementation plan in Annexure B, on the strength of their proposal that this will create sustainable and meaningful jobs for the selected beneficiaries.

- 2.1. This Agreement shall commence on the signature of the last signing party and shall remain in force for a period of 36 months unless terminated earlier in terms of breach and termination clause contained in the Agreement's Terms and Conditions attached hereto as **Annexure E**.

Should the Partner fail to commence with the Job Creation Programme within 60 (Sixty) Days from the specified timeframe reflected in the Implementation Plan, the UIF will be entitled to invoke the breach clause contained in the Agreement's Terms and Conditions and claim any amount paid to the Partner with interest.
